Dear FMA Member,

Welcome to your February grassroots update. We hope you had a wonderful President's Day Weekend. The goal of these communications is to inform you about the critical issues facing FMA, the responses of our national office team and leadership, and the many ways you can help. We are very excited about the work we are doing with the 116th Congress.

This month we are celebrating several major victories that you helped to achieve. First, after many weeks of tremendous public pressure, lawmakers and administration finally ended the longest government shutdown in our nation's history. Feds from all walks of life said enough, is enough forcing the passage of a three-week continuing resolution (CR) in order to find a long-term funding solution. As those three weeks came to a close, the resulting pressure from feds and FMA members led to passage of a long-term spending bill which included a retroactive 1.9 percent pay raise for all feds for 2019.

These victories represent major victories for FMA and could not have happened without you. Action letters represent the foundation of our grassroots work and our victories will allow FMA to advocate for more substantial reforms throughout the federal government in the upcoming weeks and months.
